Motion by J. Bruch, second by K. Pritzl to approve Agenda. Motion carried.

Motion by K. Pritzl, second by J. Bruch to approve payment of Checks (15650-15715) and Electronic Vouchers to WDOR & IRS (C20231004– C20231104) Northern State Bank in the total of \$314,916.36.

- 2. Discuss/Approve Ordinance for Lake Association: Town attorney is working on the ordinance. Will table until next month's meeting.
- 3. Discuss/Approve Paying Labor for Handicap Ramp: Motion by K. Pritzl, seconded by J. Bruch to pay Ernst \$20.00/hour for his 19 hours of labor he has into the handicap ramp. Roll call vote J. Bruch-yes, K. Pritzl-yes, Ernst-abstain. Motion carried.
- 4. Discuss/Approve Workhorse Payroll Option for Direct Pay: Clerk called Workhorse and the only option that would work is if the town purchased their own payroll program which would cost \$675.00. Board didn't not think this was a priority and voted against it.
- 5. Discuss/Approve Stumpage for gravel: Bruch wanted the board to review the price that they are paying for stumpage for gravel. The board is currently paying \$0.75/yard. Motion by Ernst, seconded by K. Pritzl to increase the stumpage for gravel from \$0.75 to \$1.25. Roll call K. Pritzl-yes, J. Bruch-abstain, Ernst-yes. Motion carried.
