April 14, 2026

Motion by J. Bruch second by K. Pritzl to approve the agenda as presented. Motion carried.

Motion by K. Pritzl, second by J. Bruch to approve March 18, 2026, Regular Meeting as printed. Motion carried.

Motion by J. Bruch, second by K. Pritzl to approve payment of Checks (16654-16682, C20260305-C20260403) in total of \$43,691.21. Motion carried.
