1. Update on Grinding Bid from Lepke: This is information to inform board that the \$2,000.00 is for mobilization and may not be as much as the Town of Lake will be doing their section of road also.

- Discuss/Approve Speed Limit Sign on West Rd Follow Up: Talked with Ashland County Sheriff's
