Town Board Proceedings

July 20, 2021

Meeting of the Town Board of the Town of Chippewa was called to order on July 20, 2021 @ 6:10pm. At roll call the following were present: Town Supervisors–Bill Ernst and John Bruch, Chairperson-Dan Koch, Clerk-Cindy Pritzl, Town Employee–Roger Eder, Chuck Miesbauer and Eric Sitte, Town District Representative – Kathy Schutte.

Motion by Ernst, second by Bruch to approve Agenda. Motion carried.

Motion by Bruch, second by Ernst Bruch to approve payment of Checks (14628-14665) and Electronic Vouchers to WDOR & IRS (C20210701 – C20210705) Northern State Bank in the total of \$24,376.60. Motion carried.
