

Town of Chippewa: Minutes

Town Board Proceedings

August 25, 2021

Meeting of the Town Board of the Town of Chippewa was called to order on August 25, 2021 @ 5:30pm. At roll call the following were present: Town Supervisors–Bill Ernst, Chairperson-Dan Koch, Clerk-Cindy Pritzl, Town Employee–Roger Eder, Chuck Miesbauer and Eric Sitte, Sales Rep from Midland Services – Steve Thurber.

Motion by Ernst, second by Koch to approve Agenda. Motion carried.

Motion by Ernst, second by Koch to approve payment of Checks (14666-14706) and Electronic Vouchers to WDOR & IRS (C20210801 – C20210803) Northern State Bank in the total of \$86,652.40.

1. Discuss Options for New Gravel Pit: Board agreed to table until we hear from Matt @ Ashland County Highway Department. Koch also questioned if we could investigate an old pit that he believes isn't closed.

New Business:

1. Approve CMMA Charitable Account: Motion by Koch, second by Ernst to approve the American Legion Post #272 as our charitable account. Motion carried.
2. Discuss Closure of Bruch Pit (Schroeder's Pit): Ernst meet with Matt at Ashland County Highway Department. Matt informed him that the pit slope is good, but the topsoil needs to be put back and it needs to be reseeded. Ernst will contact Larry Palecek to see what he would charge to fix this pit.
3. Discuss Damage to Vehicle on Mail Route Rd: Car was damaged after we dumped dirt on Mail Route Rd. without any signage. Town's insurance will not cover the damages. Estimate came in from O'Riley's Auto for \$281.64. Motion by Ernst, second by Koch to pay the \$281.64 to Robert Mallak. Motion carried.
4. Discuss/Approve Prices for LP & Fuel: Steve from Midland gave a presentation and presented the board with prices. Board agreed to table until full board was here next month.
5. Review/Approve Snowplow Contracts for 2021-2022: Board agreed for price to stay the same at \$130.00 on or before October 31, 2021 or \$180.00 on or after November 1, 2021.
